

TRADING IN MINDARK SHARES

As you may have heard, MindArk – the company behind Entropia Universe – has been approved for trading on Spotlight Stock Market, a Swedish stock exchange/MTF. Trading of MindArk's shares will begin on the 27th January 2023.

The listing is a significant milestone for MindArk and something we have been working towards for many years. That being said, we would never have achieved this if not for our amazing community who explores, investigates, and drives ever forward over more than 20 years.

MindArk's listing incentivizes us as a team to work diligently for a swift and seamless transition into the Unreal Engine 5 graphics engine and to continue bringing great content to our users.

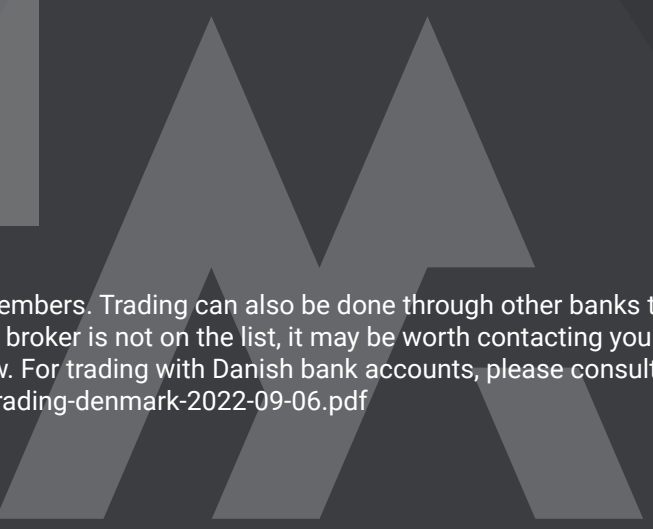
